

Line 28) We worked with the Cattlemen's Association Beef Council and University of Florida's Institute of Food and Agricultural Sciences Extension office to host a Leadership Conference. Attendees were educated on the needs of agriculture in a highly urbanized area. We discussed cattle ranching beef promotion & marketing, water quality and regulations, diversification of agriculture, agriculture's economic impact and consumer misconceptions.

Line 29) In conjunction with the county extension office, we hosted a teacher workshop. This year's focus was 'Sowing Seeds of Knowledge.' Teachers learned about active ways to get kids involved in agriculture including school gardens. By providing these workshops we promote the betterment of agriculture.

Line 30) We participated in Ag Literacy. This is a national event where members read an age appropriate book to school aged children. This ag related book helps children understand the importance of agriculture and why farming is important.
