THE CUSHMAN SCHOOL FOUNDED AND CURATES TEDX YOUTHIAMIAMI, A COMMUNITY EVENT AND PLATFORM FOR CHILDREN AND YOUNG ADULTS BETWEEN THE AGES OF 6 AND 25 TO SHARE IDEAS WORTH SPREADING. PARTICIPANTS REPRESENT THE PUBLIC AND PRIVATE SECTORS FROM ELEMENTARY SCHOOL THROUGH AND BEYOND THE COLLEGE YEARS. THE OUTREACH PROGRAM OFFERS SCHOLARSHIP PROGRAMS TO CHILDREN WHO WOULDN'T OTHERWISE BE ABLE TO ATTEND THE CUSHMAN SCHOOL.
