	<p>Sacred Heart Foundation was established in 1984 to support and further the mission of Sacred Heart Health System to improve healthcare and social services for the sick and poor of all ages in our region. The Foundation is focused on its Second Century Campaign of providing tomorrow's healthcare today. This two-part campaign is focused on building a new Children's Hospital named The Studer Family Children's Hospital at Sacred Heart in Pensacola, Florida to include a Pediatric Emergency Department and Trauma Center, six pediatric-dedicated operating rooms, an expanded Neonatal Intensive Care Unit, a pediatric intensive care unit, pediatric satellite pharmacy, a pediatric inpatient rehabilitation gym, child life playrooms, an expanded Pediatric Oncology Unit, and extended stay/observation beds. In Destin, Florida, the campaign is focused on a four phase expansion at Sacred Heart Hospital on the Emerald Coast to include a 12-bed inpatient expansion, a 12-bed Family Birth Place expansion, a 13-bed Emergency Department expansion, and a new 10-bed Level II Neonatal Intensive Care Unit. The Sacred Heart Foundation also leads the fundraising efforts for the local Children's Miracle Network Hospitals where 100% of the funds raised support the sick and injured children treated at The Studer Family Children's Hospital at Sacred Heart. The Foundation also supports Sacred Heart Cancer Center to enhance the level of cancer care in Northwest Florida and Baldwin County, Alabama.</p>
