Miami Homes for All is our namesake initiative that focuses on addressing the severe shortage of housing for cost-burdened families households and working professionals in Miami-Dade County documented at over 45,000 cases. The initiative aims to enlist funders, government, developers, and community groups to alleviate this housing shortage by pooling resources to promote mixed-income, multi-family developments. This initiative complements the traditional work the organization of advocating for the rights of individuals and families experiencing homelessness. This year, the organization released a publication detailing the needs of housing in our county.

The Youth Homelessness Initiative YHI is a county-wide collaborative effort to create a locally designed comprehensive system of care to prevent and address youth homelessness in Miami-Dade County. The Youth Homelessness Initiative is comprised of eight committees, including the issues areas prioritized under the USICH framework, as well as Data Research, Funding, Youth Engagement, and a Youth-led Advisory Council.

Chronic Homelessness - Miami Homes for All, Inc is dedicated to addressing chronic homelessness primarily by monitoring the quality of service delivery and programs designed to address the needs of those who experience homelessness within Miami Dade County. Miami Homes for All also works on its Chronic Homelessness Initiatives through collaboration and philanthropy aimed at supporting existing programs within the county to provide supplemental services such as childcare, street prescription administration, legal counsel, and job training programs.
