This was the result of two organizations both serving the same audience, and for similar purposes, coming together. NEMA filed with Illinois to do business as Friends of Nazareth. Also, on August 25, 2015 NEMA appointed Donna P. Chisam, Executive Director of Friends of Nazareth, A NEMA Corporation. The former NEMA Board resigned and approved a new Board for Friends of Nazareth, A NEMA Corporation. The headquarters for Friends of Nazareth, A NEMA Corporation moved to Cumming, GA where Ms. Chisam resides. The new Board changed the by-laws to reflect the new location. Otherwise, the NEMA by-laws remained intact.
