In setting the compensation of the President in the President's current contract, the Committee employs an independent consultant who provides an assessment of compensation from comparable presidents at comparable colleges. For the current contract, the consultant provided recommendations to the Committee, which then made recommendations to the entire Board of Trustees. The Board of Trustees approves the base salary for the President under the current contract, and has established a maximum percentage for any annual incentive compensation. Each year, in connection with the evaluation of the President, the Committee makes recommendations on any incentive compensation for which the President is eligible, subject to the approval of the Board of Trustees. Written documentation of contract discussions, approvals, attendance, and action taken are maintained on campus by a non-Board member. The President is currently completing the second year of a five-year contract.
