In addition, Rose Hill is used on occasion to house overnight guests of the Seminary. In exchange for this relationship, the use of Rose Hill as a residence for the president is provided as a non-taxable fringe benefit for as long as this arrangement meets the requirements of the Internal Revenue Service.
