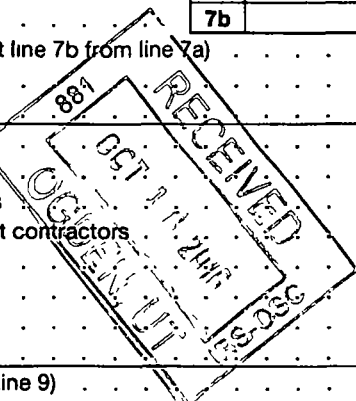



Pyramid Awards-\$22,088 grants given annually to teachers for innovative classroom instruction. Proposals are blind-scored and awards are given up to \$1000 per teacher. A total of \$22,088 was presented in Pyramid Award grants in 2015.

Arts Education & Opportunities- \$13,000 provides educational opportunities for students at Oldham County Schools Arts Center by visiting each school in the district to work directly with students by the Artist in Residence.

\$6594 donated to the english language department of the Oldham County School District to provide materials for student use in that depart. \$500 North Oldham High School and Middle School's libraries.

\$500 donated to project graduation that provides an event for graduating seniors on the night of graduation for a safe, fun and drug, alcohol free environment.
