PAFE'S TEACHER GRANTS ARE AWARDED ON AN ANNUAL BASIS TO TEACHERS WHO COMPETE FOR AVAILABLE FUNDS. AWARDS ARE BASED ON INNOVATION, COLLABORATION, IMPACT ON EDUCATION, AND A COST-BENEFIT ANALYSIS. EXAMPLES INCLUDE CLASSROOM TECHNOLOGY, LAB/SAFETY EQUIPMENT, MUSICAL INSTRUMENTS, ROBOTICS, MATH AND BOOK CLUBS, AND MORE. IN ADDITION, A CENTER FOR COVERING COLLEGE APPLICATION PROCESS, SAT AND ACT TESTING, AND FINANCIAL AID WAS FUNDED. THIS YEAR, WE PROVIDED TEACHER GRANTS TO 52 TEACHERS BENEFITING 3500 STUDENTS.

IT PROVIDES A COMMON APPROACH TO WRITING, SAME METHODOLOGY BUT INTENSIFYING EVERY YEAR, SAME TERMINOLOGY, SAME FORMAT, SAME HIGH EXPECTATIONS. THIS PROGRAM IS STATE-OF-THE-ART IN DEVELOPING RIGOROUS COMMUNICATION SKILLS, AND THE NEW AND CHALLENGING WRITING EXPECTATIONS OF ALL STUDENTS NATIONWIDE. THIS PROGRAM SERVES ALL STUDENTS IN THE LPO SCHOOL DISTRICT, APPROXIMATELY 3500 STUDENTS PROVIDED 50,000 FOR INSTRUCTIONAL COACHES. THESE COACHES ARE CONSIDERED TO BE ONE OF THE MOST POWERFUL ASSETS TO MODERN EDUCATION. COACHES ARE A VITAL RESOURCE FOR ALL EDUCATORS IN THE LPO SCHOOL DISTRICT. THEY INSTRUCT ALL TEACHERS TO BE THE BEST THEY CAN POSSIBLY BE, BECAUSE EFFECTIVE TEACHERS MATTER MORE TO STUDENT ACHIEVEMENT THAN ANY OTHER ASPECT OF SCHOOLING. THIS PROGRAM SERVED APPROXIMATELY 300 TEACHERS IN THE LPO SCHOOL DISTRICT WITH TWO COACHES.
