THE FOUNDATION NOW PROVIDES FINANCIAL SUPPORT FOR TWENTY-TWO SCHOLARSHIP PROGRAMS FOR THE COLLEGE. THE AWARDS RANGE FROM 120 TO 750 PER SEMESTER TO ASSIST IN THE COST OF TUITION, BOOKS AND FEES, WITH 17 STUDENTS RECEIVING FINANCIAL SUPPORT THROUGH THE FOUNDATION DURING THE FISCAL YEAR ENDED JUNE 30, 2016. ADDITIONAL FINANCIAL SUPPORT WAS PROVIDED TO ASSIST APPROXIMATELY 96 HIGH SCHOOL STUDENTS IN OBTAINING COLLEGE CREDIT THROUGH AP COURSES PROVIDED AT THEIR LOCAL HIGH SCHOOLS.
