OVER THE PAST FISCAL YEAR WE COMPLETED 12 MAJOR CONSERVATION TRANSACTIONS DISCUSSED BELOW WHICH PROTECTED 988 ACRES OF KEY MOUNTAIN LANDS. THIS INCLUDES 6 FEE SIMPLE PURCHASES, 1 FEE SIMPLE DONATION, 2 CONSERVATION EASEMENT PURCHASES, 1 CONSERVATION EASEMENT DONATION, AND 2 ASSIST TRANSACTIONS. THE TOTAL VALUE OF THESE TRANSACTIONS WAS \$5 MILLION. LANDOWNER DONATION VALUE WAS \$1 MILLION. THE PURCHASE PRICE OF THE TRANSACTIONS WAS \$4 MILLION. THIS AMOUNT CAME IN THE FORM OF PRIVATE PHILANTHROPIC CONTRIBUTIONS, DONATIONS, LOANS AND FEDERAL, STATE, AND COUNTY GRANTS.
