SUSTAINING MEMBERS ARE THOSE MEMBERS WHO PROVIDE ADDITIONAL FINANCIAL SUPPORT TO THE SOCIETY BY PAYING AT LEAST 1 1/2 TIMES THE DUES PAID BY OTHER MEMBERS. RESIDENTS, FELLOWS, AND TRAINEES WILL BE ASSOCIATE MEMBERS, ENTITLED TO PRESENT THEIR OWN PAPERS AT MEETINGS, BUT ONLY FULL MEMBERS ARE ELIGIBLE TO VOTE. EMERITUS MEMBERSHIP IS AN HONORARY STATUS THAT MAY BE CONFERRED BY VOTE OF THE MEMBERSHIP AT THE REQUEST OF A PREVIOUS ACTIVE MEMBER WHO HAS RETIRED FROM PRACTICE OF HEMATOLOGY. HONORARY MEMBERSHIP MAY BE BESTOWED ON OUTSTANDING INDIVIDUALS UPON PROPOSAL BY THE EXECUTIVE COMMITTEE AND APPROVAL BY VOTE OF THE MEMBERSHIP.
