One hundred percent of Tnnity graduates are accepted in post-secondary institutions. At Tnnity, we hire master educators who thoughtfully and strategically utilize technology as a tool to enhance teaching and learning. Trinity's intense commitment to the arts is readily apparent by state-of-the-art areas for dance, choral, instrumental, art and speech. Trinity is the only independent school in Montgomery that offers a full-time dance program.
