The center consists of six classrooms, which includes two baby rooms, two 1-year old rooms, one 2-year-old room and a 3-4 year old room for a combined full day enrollment of 65. While enrollment opportunities are open for all families, preference is given for those living in the Midtown community with scholarships being available for those families who might be experiencing an economic barrier.
