monitored network of food banks that covers all 67 Florida counties. Feeding FL is affiliated  
with Feeding America, the nation's leading hunger relief organization. Each Feeding FL food  
bank must meet stringent guidelines to be associated with Feeding America. This contracted  
relationship assures both financial and operational excellence. It also provides  
accountability through network training, site monitoring, and the maintenance of substantial  
records verifying conformity to established Federal and State food handling standards
