Briefly describe the organization's mission

The mission of Summer on the Hill (SOH), a year-round, supplemental academic program, is to enrich the education of promising, low-income public school students from the Bronx, Washington Heights, and Harlem, prepare them for selective schools and colleges, and offer guidance to their parents. SOH is a unique NYC program that enrolls promising students at the elementary level and works with them through high school--for ten years. Each year, SOH challenges 250 students with accelerated academic classes, school and college test prep classes, and instruction in the arts and sports. We offer 5th, 8th and 12th graders individual guidance on school and college choices. Although housed on the campus of the Horace Mann School with access to the School's facilities, SOH is an independent 501(c)(3) program that raises its own funds to operate a high-quality program.

Since its establishment in 1994, Summer on the Hill (SOH) has offered important educational opportunities to 1,600 promising, low-income public school students from the Bronx, Washington Heights, and Harlem. The average annual income of SOH families is \$65,000 and only one third of current SOH parents hold a college degree. Despite many challenges, each year, 250 SOH students actively participate in the program. The range of achievement at SOH includes Attendance and Attention. Students in the Grade 3-8 Program demonstrated their enthusiasm for SOH by attending the academic year Saturday program -- a sixth day of school - at the impressive attendance rate of 90%. SOH's attention rate is approximately 5% yearly. Middle School Placement. SOH has placed over 200 elementary level students in independent schools. Without SOH's guidance, it is unlikely that families would have known about and applied to the schools listed here (all SOH students attending independent schools receive enough financial aid to make their enrollment possible). SOH has placed students at the George Jackson Academy, De La Salle Academy, and Horace Mann's Middle School as well as Fieldston Ethical Culture, Nightingale-Bamford, Riverdale County School, Speyer Legacy, and St Bernard's High School Placement. Between 2010 and 2016, 42 SOH students were accepted to specialized NYC public high schools. Bronx Science (18), Brooklyn Latin (1), Brooklyn Tech (9), HS for American Studies at Lehman (6), HS for Math, Science, and Engineering at City College (9), LaGuardia HS (5), and Stuyvesant (3). During this period, students were also accepted to boarding schools (St. Paul's, Phillips Exeter), Catholic schools (Mt. St. Ursula, Fordham Prep), and independent schools (Horace Mann, Riverdale). College Placement. Over 90% of SOH's 2004-2016 high school graduates matriculated at over 125 colleges and universities, including Amherst, Barnard, Bates, Boston College, Bowdoin, Brown, Carnegie Mellon, Columbia, Cornell, Dartmouth, Duke, Harvard, Middlebury, MIT, NYU, Smith, Swarthmore, SUNY Binghamton, University of Pennsylvania, and Yale. SOH college graduates are working in education, finance, health, insurance, and technology, or are enrolled in graduate or medical schools. Awards. In March 2009, Dr. Maivor, SOH's Executive Director, received the Lewis Hine Distinguished Service Award for expanding educational opportunities for low-income youth. Recognition from Foundations. Since 1994, SOH has received over \$11 million in grants and individual gifts. Recent grants have been awarded by these foundations: Altman, Austin, Baldwin, Colgate-Palmolive, Davis, Donchian, Gerstner Family Foundation, Charles Hayden, Heisman Trophy Trust, Niles, Oaklawn and the New Yankee Stadium Community Benefits Fund. Three New York City Councilmen have awarded discretionary grants to SOH. The NYC Department of Education and the NYS Department of Health have supported SOH's meal programs. SOH is deeply grateful to the Horace Mann School for its gift-in-kind of facilities and supportive services.
