Project Learn is a comprehensive program covering educational, prevention, sports, recreational and art services. It impacted approximately 3,550 bonafide residents from different housing projects within the ages 6 through 18; and 900 adults through its Family Support program. Activities supported included: Power Learning (848 participants), Drug Prevention (445 participants), Leadership Program (99 participants), Performing Arts (427 participants), Sports and Recreation (1,738 participants) and Family Support (902 participants). These programs are carried out through different programs including Power Hour, Torch Club, Keystone Club, Goals for Graduation, Visual Arts, Dance and Theater, and Sports and Recreation. For fiscal year 2015-2016, 100% of program goals presented to PRPHA were accomplished. Major program results were as follows: 100% of participants graduated from high school and 89% of those will continue post secondary studies. In the Health and Life Skills program, 94% of participants abstain from using alcoholic beverages, tobacco and/or marijuana

21ST CCLC is a comprehensive program covering educational, prevention, sports, recreational and art services. Its main objective is to improve academic progress, as well as technology skills of participants. During fiscal year 2015-2016, 1,300 participants between the ages 6 and 18, and 225 parents benefited from the program. Services provided included tutorships, homework assistance, Spanish, English, reading, character development, art, sports and recreational activities. Program results statistics were as follows:

* 100% of participants attended services for 30 days or more

* 784 (60%) participants finish the school year with A or B grades in Spanish courses

* 600 (46%) participants increase their Spanish grade by .25 grading points

* Approximately 99% of participants pass grade

* Parents of participants took part of educational forums and employment opportunities forums, family time management and healthy life styles workshops.

Program addressed to prevention services through SMART Moves module. Main objectives are to promote autosufficiency in head of household women, and youth activities directed toward preparation for employment, encouraging responsible maternity and paternity, and activities directed to prevention of unplanned pregnancies. During fiscal year 2015-2016, the program benefited 586 youth participants and 431 parents. A Family Strengthening Conference and a Youth Prevention Workshop were realized during the fiscal year. 100% of programmatic objectives were achieved.

The Organization provides other services funded through Private Foundations, Local Government grants and Federal Campaigns. The Organization provides drug prevention and family support programs as well as mentoring through science and other subjects.

* Mentoring and Leadership Program. Sponsored by OJP, is a prevention and mentorship program for youth in risk. Organization provided character and leadership development, educational and career development, and health and life skills. The program benefited 134 participants from different clubs, been able to follow up on each one of them individually; and all of them accomplishing program objectives.

*Alcohol Prevention: Sponsored by San Juan Municipality, program was directed to the prevention of sale and consumption of alcohol to minors. A total of 5,382 participants were reached by this initiative. 100% of programatic objectives were achieved.

*Prevention and Mentorship through Science: Sponsored by the Sea Research Foundation, program was directed to the prevention and mentorship of youth through science. A total of 120 participants between 6 and 9 years old were reached by this program, and 98% of the participants attended at least 18 educational sessions.
