THE ARKANSAS STATE EMPLOYEES ASSOCIATION CONSISTS OF APPROXIMATELY 15,000 ACTIVE EMPLOYEES OF THE STATE OF ARKANSAS, AND ANOTHER 1,000 RETIRED AND ASSOCIATE MEMBERS. THE FOLLOWING IS A LIST OF ACCOMPLISHMENTS IN FY 2016: THE ASSOCIATION DRAFTED LEGISLATION IN 2015 TO CREATE A TASKFORCE TO INVESTIGATE STATE OF ARKANSAS RETENTION AND TURNOVER. THE TASKFORCE IS MADE UP OF 10 MEMBERS WITH ASEA ASSISTANT DIRECTOR AS CHAIR. ASEA COVERS THE ADMINISTRATIVE AND TRAVEL REIMBURSEMENT COST OF THE TASK FORCE TO ENSURE THERE IS NO COST TO THE STATE. DURING FY 2016, ASEA HELD PUBLIC FORUMS ACROSS THE STATE TO ALLOW STATE EMPLOYEES TO LISTEN TO THE ASSOCIATION'S IDEAS ON INCREASING RETENTION AND EXPRESS THEIR VIEWS AND IDEAS. PUBLIC FORUMS WERE HELD IN HOPE, BATESVILLE, ROGERS, JONESBORO, AND LITTLE ROCK. THE ASSOCIATION HAS BEEN WORKING CLOSELY WITH THE OFFICE OF PERSONNEL MANAGEMENT WHILE THEY WORK ON A NEW PAY PLAN FOR STATE EMPLOYEES. MEETINGS WERE ALSO HELD WITH THE GOVERNOR, LT. GOVERNOR, AND KEY ELECTED OFFICIALS TO SHARE FINDINGS AND SUGGESTIONS FOR INCREASING RETENTION LEVELS. AS A RESULT, MANY OF OUR SUGGESTIONS HAVE BEEN INCLUDED IN THE NEW PAY PLAN THAT WILL BE PRESENTED BEFORE THE GENERAL ASSEMBLY IN JANUARY 2017. IF PASSED, THE PAY PLAN WILL HAVE A POSITIVE MONETARY IMPACT FOR ALL STATE EMPLOYEES. THE ASSOCIATION CONTINUES TO TRAVEL ACROSS THE STATE HOSTING PIZZA LUNCHES TO KEEP STATE EMPLOYEES INFORMED OF OUR ADVOCACY EFFORTS. THESE MEETINGS ALSO SERVE AS A REMINDER THAT ASEA PROVIDES RETAIL DISCOUNTS, SCHOLARSHIPS, AND A BENEVOLENT FUND FOR ITS MEMBERS. THE ASSOCIATION ONCE AGAIN WORKED WITH THE OFFICE OF PERSONNEL MANAGEMENT TO PROVIDE OFFICIAL TRAINING WORKSHOPS AT NO COST TO THE STATE. THE PROFESSIONAL DEVELOPMENT WORKSHOPS INCLUDED "HOW TO HANDLE EMERGENCY SITUATIONS AT THE WORKPLACE AND "HOW TO DEAL WITH DIFFICULT CUSTOMERS". THE ASSOCIATION HELD THESE WORKSHOPS DURING ITS ANNUAL CONVENTION AND WAS ATTENDED BY OVER 150 PEOPLE. FOR THE 2016 OUTSTANDING STATE EMPLOYEES AWARDS BANQUET, ASEA INCREASED THE MONETARY AWARD TO \$3,000 FOR THE WINNER AND \$1,000 EACH TO THREE FINALISTS. THE INCREASES WERE SUPPORTED BY SPONSORSHIPS AND FUNDING BY THE ASSOCIATION. THE ASSOCIATION ALSO FILMED THE EVENT IN ORDER TO CREATE A COMMERCIAL TO INCREASE AWARENESS AND SUPPORT FOR THE EFFORTS STATE EMPLOYEES HAVE ON ARKANSAS. THE \$1,000 JOHN F. MOTES SCHOLARSHIP WAS AWARDED TO 10 APPLICANTS IN FY 2016. THE ANNUAL SCHOLARSHIP IS DESIGNED TO ASSIST ASEA MEMBERS AND THEIR FAMILIES TO OFFSET THE RISING COST OF TUITION. BY SUPPORTING OUR MEMBERS AND THEIR FAMILIES, WE ARE SUPPORTING THE CURRENT AND FUTURE WORKFORCE OF THE STATE OF ARKANSAS. ALL RECIPIENTS ATTEND ARKANSAS UNIVERSITIES. THE SCHOLARSHIP IS FUNDED BY THE ASEA WALK OF FAME AND A PORTION OF ASEA'S ANNUAL CONVENTION SPONSORSHIPS.
