THESE INCLUDE HOUSING, QUALITY CHILDREN'S PROGRAMS, JOB TRAINING, CASE MANAGEMENT, AND MUCH MORE. OUR HOUSE SERVED 1,702 DIFFERENT PEOPLE IN FY2016, INCLUDING AN AVERAGE OF 110 RESIDENTS EACH NIGHT, AN AVERAGE OF 125 CHILDREN EACH DAY, AND UP TO 90 NEAR-HOMELESS FAMILIES EACH DAY.
