

SCHOLARSHIPS, GRANTS & LOANS - FOR ACADEMIC YEAR 2015-2016, 73 STUDENTS RECEIVED SCHOLARSHIPS FROM UHC AND 60 STUDENTS RECEIVED SCHOLARSHIPS FROM PRIVATE SOURCES. MOST STUDENTS WERE AWARDED THE SCHOLARSHIPS ON THE BASIS OF ACADEMIC MERIT AND/OR UNMET FINANCIAL NEED. OTHERS WERE GRANTED AWARDS BASED ON ACADEMIC MERIT ONLY. A TOTAL OF 133 SCHOLARSHIPS IN THE AMOUNT OF \$268,205 HAVE BEEN AWARDED.
