Adult Education: We operated an adult education program funded mainly with funds from the U.S. Department of Education and the
Louisiana Community and Technical College System. We served 158 adults in the program. We reached or bettered our NRS bench-
marks. Nine students were their alternative high school diploma and over 60% completed at least on NRS educational level.

4b (Code:) (Expenses \$ 110,086 including grants of \$ 83,965) (Revenue \$ 0)
Emergency Assistance: This program provides emergency financial assistance to individuals and families facing eviction, loss of
utilities, funerals, etc. Our food pantry also provides emergency food boxes to hungry individuals and families. During the 2015-16
fiscal year the program provided rent assistance to 79 individuals/families, utility assistance to 294 individuals/families, and other
financial assistance (funeral expenses, security deposits, state ids, bus tickets, etc) to 49 individuals/families. The program also
provided emergency food baskets to over 400 individuals/families. Staff also intervened in a variety of landlord-tenant conflicts,
neighborhood squabbles, family disputes. Staff also referred numerous people to other programs and agencies for other forms of
help and support. Our coffeehouse opened three mornings a week for free coffee and pastry, as well as TV, newspapers, and
computer access for homeless and other low income individuals. On average 25 people visited the coffeehouse on a given day.

Youth Recreation: This program provides supervised after-school recreation for children and young adults at a local gym. On
average, 40 children participate in the program on any given weekday from 3 pm to 6:30 pm.
