NAVIGATOR - SOUTHWEST LOUISIANA AHEC (SWLAHEC) WAS AWARDED A HEALTH INSURANCE EXCHANGE NAVIGATOR GRANT BY THE FEDERAL CENTER FOR CONSUMER INFORMATION AND INSURANCE OVERSIGHT (CCIIO). THE PURPOSE OF THE ONE-YEAR GRANT WAS TO ASSIST UNINSURED AND UNDERINSURED PERSONS WITH OBTAINING HEALTH INSURANCE THROUGH THE US FEDERAL MARKETPLACE AS MANDATED BY THE AFFORDABLE CARE ACT. SWLAHEC FORMED A CONSORTIUM WITH THE OTHER THREE LOUISIANA AHECS, NAMELY CENTRAL LOUISIANA AHEC, NORTH LOUISIANA AHEC AND SOUTHEAST LOUISIANA AHEC.
