Provide out-of-home care for children and therapeutic services to children and families in crisis. Cookson Hills welcomes children into a supportive family environment within a safe community. The community is based on a family-style living model. Children are placed in homes staffed by dedicated ministry-oriented house parents. They care for a maximum of 10 children, including their own in 11 homes. See Schedule O for continuation.

4b (Code) (Expenses \$ 752,479 including grants of \$) (Revenue \$)
Christian based Educational Services 1st - 12th grades. Our educational program is designed to meet children where they are and help them achieve at the level of their potential. As their skill and knowledge grows, their potential is expanded, enabling each child to continuously improve their academic skills and self management abilities. Results from the Iowa Test of Basic Skills reveal that, on average, our kids achieve from 1.5 - 2.0 years of progress each year they attend our school. Additionally, our average composite ACT test scores (25.5) rank our high school in the top 10 high schools in the state of Oklahoma. Our average score exceeds other alternative schools by 9.9 points.
