Hunger Reduction: Three out of ten households with children in the Tulsa area do not know when they will eat again. This is something Restore Hope is committed to change. Last year we distributed 221,943 pounds of nutritious groceries to help 4005 families fight hunger and put food on the table for themselves and their children.

4b (Code:) (Expenses \$ 244,147 including grants of \$) (Revenue \$)

Homeless Prevention: Our Homeless Prevention Initiative provided rent assistance for individuals and families at risk of becoming homeless. We offer rent assistance for families who can document a recent and unexpected loss of income and are facing eviction. Last year we provided assistance to prevent homelessness for 612 individuals at a 100% success rate (compared to a national average of 70% success in preventing families from packing up their lives and moving into shelter or onto the streets).

Hope Promotion: When a crisis strikes, more than just one's physical well-being is impacted. The crisis itself can be emotionally damaging but the fact that one must seek aid also affects one's sense of worth. Restore Hope seeks to address these needs through daily (optional) chapel services, volunteer prayer counsellors, and chapel staff. Last year, 1196 people visited one of our chapel services, 504 people received a new Bible, 190 shared communion, and 78 found a new church home.
