The organization published its Lynn Lifestyle Summary February 29, 2016, and launched a 35-member, select Collaborative of community leaders. The Group met monthly and reviewed the 92-page book, identifying the critical issues and developing goals for what the community should be by 2026 (10 year goals). The Collaborative then worked to develop two year tasks in each of the events. The 10 year goals, by category, developed are as follows: - Health 2026 Goal: Northeast Oklahoma City will have a population that exhibits strong mental, physical, and emotional lifestyles. - Transportation 2026 Goal: Northeast Oklahoma City will have a transportation system which efficiently and affordably helps residents and visitors easily access all the assets and services of the area. - Economy 2026 Goal: Northeast Oklahoma City will have a sustainable economy which encourages and energizes healthy, robust lifestyles. - Community 2026 Goal: Northeast Oklahoma City Community will have a culture of strong family units and will celebrate learning & education. - Environment 2026 Goal: Northeast Oklahoma City is a preferred living destination featuring safe and beautiful spaces to live, work, and be healthy. Lynn also worked with Crossings Community Center & Clinic and during the summer of 2016 worked to develop a Lynn Lifestyle Summary for four area zip codes, focusing on zip code 73114.
