St John's is an independent, co-educational day school presenting a 13-year sequence of college preparatory training. A non-profit institution, it was founded in 1946 to provide the community with a school of exacting standards in the development of individual, spiritual, ethical, intellectual, social and physical growth. While the means to achieve that purpose may change, it remains the basic mission of the School.

St John's School provides approximately 1,325 talented students in grades K-12 with a rigorous college preparatory curriculum and a wealth of enrichment opportunities carefully designed to prepare students for lives of leadership, service, and personal fulfillment. The School seeks to develop the whole person in preparation for a lifetime of personal fulfillment and contribution to society. In particular, it is dedicated to the enhancement and the expansion of future leadership for Houston and the country. The School offers talented, motivated and energetic students a genuine challenge for academic accomplishment and for development of a sense of self-worth and of personal responsibility. The School in turn holds itself responsible for providing that challenge.

Breakthrough Houston (BTH) is a tuition-free program for academically gifted students from underserved families in the Houston community. The program makes a six-year commitment to its students, starting the summer before 7th grade and lasting until high school graduation. Middle school students participate in an academically rigorous six-week Summer Program and a School Year program made up of ten school-year Saturday enrichment sessions. High school students participate in a four-year college preparatory program made up of ACT prep, college visits, and resume building opportunities. BTH, part of the national Breakthrough Collaborative, is a joint venture of St John's School (SJS) and Episcopal High School. Both schools co-host the program by making their campuses available for BTH to operate. BTH operates under the 501(c)(3) designation of SJS and SJS acts as the fiscal agent for BTH.

The Corporation made changes to its Articles of Incorporation (now called its Restated Certificate of Formation under Texas law) and Bylaw s during the tax year ended June 30, 2016 None of these changes related to the exempt purpose for w hich the Corporation w as formed (i e , to promote education through the ow nership and operation of a school located in Houston, Texas) Rather, these changes w ere enacted primarily to maintain conformity w ith current best practices for tax-exempt nonprofit corporations w ith respect to both Texas and Federal law For example, as permitted under Texas law , and in order to enhance the efficient administration of the Corporation, the documents w ere revised to specifically authorize the Corporations Trustees to take action in lieu of a formal meeting by the w ritten vote of tw o-thirds of the Trustees Also, in order to enhance consistency and interpretative ease, certain actions that previously required the affirmative vote of 61 5% of the Trustees now require the vote of tw o-thirds of the Trustees In addition, to account for the population grow th in the counties surrounding the county in w hich the school is located (i e , Harris County), the documents w ere revised to clarify that students may be accepted to the school irrespective of the county in w hich they reside Finally, the documents w ere revised to clarify that in the event that the Corporation w ere to dissolve, the Trustees of the Corporation w ould have the discretion to determne w hich organizations exempt from federal income tax under section 501(c)(3) of the Code or described by section 170(c)(1) or (2) of the Code w ould receive the Corporations assets
