The amount that is ultimately sustained for an individual uncertain tax provision or for all uncertain tax positions in the aggregate could differ from the amount recognized. Interest and penalties associated with uncertain tax positions are recognized as components of federal income tax expense. The Food Bank did not have any interest or penalties with regard to uncertain tax positions during the years ended June 30, 2015 and 2014. As noted above, the Food Bank is a tax-exempt non-profit organization, therefore, no provision or liability for federal income taxes has been included in the financial statements. The Food Bank believes that its tax position regarding its status as a tax-exempt organization will remain significantly unchanged within the next twelve months. While the Food Bank is not aware of any tax examinations being conducted, tax years 2012-2014 remain subject to examination by the United States Internal Revenue Service.
