An income tax provision has been made in the accompanying consolidated financial statements for the federal income tax for PHCS and certain affiliates. The provision for current federal income tax was \$15,196 and \$6,288 for the years ended June 30, 2016 and 2015, respectively. The Corporation's for-profit Affiliates have adopted FINANCIAL ACCOUNTING STANDARDS BOARD, ACCOUNTING STANDARDS CERTIFICATION (ASC) 740, INCOME TAXES, which requires an asset and liability approach for financial accounting and reporting for income taxes. The Corporation had no deferred tax assets or liabilities at June 30, 2016 or 2015.
