The mission of KidWorks is to restore at-risk neighborhoods one life at a time. The Organization builds on the strengths and potential in the community through education, character formation, and personal development. The goals of KidWorks are to 1) be a model of community transformation by building on existing community assets, 2) be a safe haven for youth and families, and 3) be a place for learning, nurturing, and leadership development. KidWorks serves over 800 at-risk children, youth and parents in weekly programs and over 3,000 community members annually at 4 community centers in central Santa Ana, CA.

The After School Program places nearly 450 students on a direct path towards college by equipping them with the right tools. Beginning in kindergarten and continuing through high school, children participate in age-appropriate activities that prepare them for higher education through academic and character building activities, including tutoring, mentoring and college preparation. In addition, KidWorks offers workshops on art, science, music, dance, creative writing and more. KidWorks provides financial literacy workshops and teaches students how to make prudent financial decisions through a robust understanding of finances and life economics. KidWorks also offers education on nutrition, healthy eating choices, cooking classes, exercise classes, and ways to live healthier lives. Students have access to weekly fitness activities and sports leagues. In 2015-2016, the After School Program served an additional 100 students and youth during the fiscal year and added a fourth satellite center within the community. 91% of K-3rd grade students testing below grade level in reading improved their score and 90% of K-3rd grade students testing below grade level in math improved their score. 100% of KidWorks' high school students graduated in four years. 100% of parents and 90% of children, K-8th grade, increased their knowledge of good nutrition and healthy living practices. 100% of high school seniors graduated on time and enrolled in college or university this Fall Semester.

Youth and Family Engagement Program builds and develops leaders who give back and serve their community. KidWorks' youth participate in student government, volunteer as tutors and mentors, engage in civic processes of the city, and perform service projects. KidWorks' parents participate in parenting workshops, support groups, educational classes, and community service projects. In 2015-2016 a total of 201 parents participated in regular parent training and activities. 288 youth participated in civic leadership projects and community events with KidWorks. Students in the program submitted a grant proposal to the State of California, which the State recommended for approval, to install protected bike lanes in the City of Santa Ana. Over 600 corporate volunteers worked alongside students and parents to beautify a community neighborhood in May. KidWorks parents also participate in community safety initiatives and have successfully advocated for increased lighting at local city parks. Students also worked in partnership with the Santa Ana Unified School District to reintegrate salad bars at local high schools.

KidWorks operates a licensed preschool serving 48 students daily. The majority of students start preschool speaking no English. The primary goal is a successful transition from preschool to kindergarten for every child and family. 100% of KidWorks' preschool students were assessed as kindergarten-ready by the end of the school year.
