	See Schedule O Baylor Health Care System Foundation (Foundation) raises and manages charitable funds to support Baylor Scott & White Health and its charitable affiliates (System) achieve their mission of serving all people through exemplary health care, education, research and community service. Since the Foundation was established in 1978, it has distributed more than \$593 million to Baylor Scott & White Health. It is supported by more than 11,000 active donors, including individuals, corporations and other private foundations. The Foundation has raised money through a variety of campaigns and fundraising events, all geared toward certain areas of need such as cancer care, heart and vascular, medical education, palliative care, nursing, neuroscience and other areas. Each event is designed to reach out to the community, educating citizens on various health issues, the System's mission, and actions that are essential for providing quality healthcare for the communities in which we serve. During the FYE June 30, 2016 the Foundation has distributed more than \$43 million toward these charitable activities. Below is the history of the System and how it promotes the health of the community. History - Is it not now time to create a great humanitarian hospital? These immortal words, often quoted as the creation of the System, were delivered by a celebrity speaker after dinner at a fundraising event in 1903. Rev. George Truett not only delivered these carefully crafted words, but also encouraged one attendee - Colonel C. C. Slaughter - to be the first, transformational donor to support the vision of Baylor Scott & White Health. The Foundation carries this tradition today by hosting similar events and campaigns to inspire the transformational gift that will affect generations to come. Medical Education - Many people are unaware of the importance of a thriving, hospital-based teaching facility. Naturally, we are proud of providing the next generation of physicians with peerless preparation for their role in a complex society. But a strong student corps makes us better too. The ability to recruit the best and brightest medical students, residents and fellows builds leadership across numerous fundamental and interdisciplinary domains. A rich academic environment will drive contributions to society in the years ahead. It is no secret that we face a potentially dire shortage of physicians, as well as declining government funding for medical education. Teaching hospitals are experiencing keen competition for top candidates. To prevail, substantial new resources are needed. These funds will endow positions for residents and fellows to continue the creation of medical leaders for the future. Every year, more than 230 residents and fellows are trained at Baylor University Medical Center at Dallas. As one of the Southwest's major hospital-based teaching facilities, we do more than prepare the next generation of physicians. Our rich academic environment makes us a better hospital. Cultivating the best and brightest residents and fellows invigorates our medical staff, strengthens our relationships with first-rate physicians and forges meaningful bonds with leading medical schools. The passion ignited by our drive to push the boundaries of medicine touches our patients as well. Medical Research - The System attracts world-renowned physician-scientists who seek a vital, supportive institution within which to conduct clinical research. Large patient volumes create an especially fertile environment for this translational, bench-to-bedside discovery. We are routinely sought after to participate in clinical trials that offer potential life-altering results for the patients we serve, today. Every year, hundreds of clinical trials are conducted within our system. The collegial and collaborative System culture also positions us at the forefront of the new biomedical frontier. A core belief is that these potentially life-saving breakthroughs are only as valuable as our ability to share them with the entire community, and indeed the world. At a time when corporate and government support for research has substantially declined, philanthropy is vital to the ability to endow research chairs, recruit more physician-scientists, and buy and build state-of-the-art equipment and laboratories. PROGRAMS - At the core of the System vision is a community transformed by health and wellness. What must we provide to keep a community healthy? Awareness - We must help people take control of and responsibility for their health. Teaching people to recognize the warning signs of illness and assisting them as they attempt to navigate fragmented health care systems. Prevention - We must change the paradigm in our current system to focus on avoiding illness rather than dealing with it after the fact. For more than 110 years, members of our community have looked to Baylor for answers, innovation and medical leadership. We can have a real impact in the area of preventive care. Compassion - The System commitment is to care for all people, regardless of age or financial resources. And that means transporting care to neighborhoods where there are barriers of access, language and transportation. Capital - Over the years, the System has worked hard to keep up with capital demands. The System footprint is situated in one of the fastest-growing regions in the U.S. Many System facilities have aged or become obsolete as a result of regional growth, along with advances in science and technology. Capital for equipment, laboratories and other types of facilities will always be at the top of our philanthropic wish list. With some \$9.7 billion in total assets - much of which is several decades old - depreciation and obsolescence is a given. At the forefront of change, the System must continue to provide patients and their families with physical spaces that advance therapies and nurture healing.

The organization, a controlled affiliate of BSW Holdings, recognizes that those chosen to lead the organization are vital to its ongoing success and growth. Thus, it must attract, retain and engage the highest quality officers and key employees to lead the organization and help the organization maintain its national reputation for achieving high targets for medical quality, patient safety, and patient satisfaction. A significant portion of the organization's officers and key employees' total compensation is based on significant performance achievements. This strategy places a greater emphasis on the importance of the organization achieving targeted improvements in the areas of people, quality, patient satisfaction and financial stewardship, annually. Total executive compensation is part of an integrated talent management strategy developed by the BSW Holdings' Board of Trustees and its Compensation and Governance Committee (C&G Committee) to attract, motivate, and retain the best leadership resources for the organization. Executive compensation is determined pursuant to guidelines outlined in the intermediate sanction rules under IRC Section 4958 including taking steps to meet the rebuttable presumption standard of reasonableness under Treasury Regulation 53.4958-6, as summarized below. When making compensation decisions, the organization compares itself to similar-sized, and structured businesses including other integrated health care service systems and other similar-sized organizations, both locally and nationally. The BSW Holdings' Board of Trustees and C&G Committee, on behalf of the organization, works directly with an independent compensation expert(s) to identify reasonable and competitive market rates as well as provide an annual review of the total compensation of the system's top management officials and key employees. The C&G Committee is made up of members of the BSW Holdings' Board of Trustees, who are independent, community volunteers guided by the information provided by the independent compensation expert(s), the C&G Committee approves and recommends to the BSW Holdings' Board of Trustees salary increases, earned incentives, and/or benefit offerings for the organization's President, other officers and/or key employees to be comparable to similar organizations for similar services and/or positions. Furthermore, the C&G Committee is charged with the responsibility of reviewing annually the major elements of the executive compensation program to assure designs remain consistent with the business needs, market practices, and compensation philosophy. As part of the decision making process, the C&G Committee will often meet in executive session to discuss and review recommendations made by the independent compensation expert(s). During the executive session no officer or key employee whose compensation is being reviewed is present during these discussions. All decisions are contemporaneously documented in the C&G Committee minutes which are timely reviewed and approved by the C&G Committee.
Part I, Line 4b	In order to recruit and retain key talent, BSW Holdings and certain tax exempt affiliates (BSWH) offers a supplemental non-qualified retirement plan to eligible employees. The plan provides an annual benefit (based on a percentage of compensation) to the employee that is paid to the employee on a future date upon vesting in the plan. The following individual(s) participated in and/or received payments (noted in parenthesis) from BSWH's supplemental non-qualified retirement plan during the tax year: Rowland Robinson (\$46,006), Joel Allison (\$189,240), Amy Martin and William Boyd (\$98,483). Also, select certain officers, as designated by BSW Holdings' governing body, are eligible to participate in a Long Term Incentive Plan that is designed to recognize the key senior leaders value and contribution to BSWH as well as align their compensation to the long term strategy of BSWH. Performance targets are based upon a percentage of the participant's base salary and are developed by independent third party expert(s) using market competitive data within the guides of reasonableness. The plan is based on BSWH's three-year performance against its peers, determined based on peer rankings or percentile rankings in quality, patient satisfaction and financial performance. At the end of three years, awards are determined by BSW Holdings' governing body for participants. Payouts are partially made in cash and the remainder vests over an additional two year period. The following individual(s) participated in and/or received payments (noted in parenthesis) from this plan during the tax year: Joel Allison (\$851,281), Rowland Robinson (\$337,957) and William Boyd (\$353,352).
Part I, Line 7	The organization has adopted and implemented BSW Holdings', the organization's ultimate parent, Annual Incentive Program to provide a market competitive total cash compensation incentive program that is designed to attract and retain key leaders and establish greater individual accountability and alignment to business performance. Payout targets are based upon a percentage of base pay and are developed by independent third party expert(s) using comparable market competitive data within the bounds of reasonableness and that are reviewed and approved by BSW Holdings' governing body. Payout levels are based upon a combination of system, entity, and individual performance using various metrics related to quality, patient satisfaction, employee retention, and financial stewardship. BSW Holdings' governing body may approve modifications to annual incentive awards provided under the program consistent with market comparability data.

The members of the governing body serve on a voluntary basis and receive no cash compensation from the organization for these duties as a member of the governing body.
