See Schedule O Baylor Regional Medical Center at Grapevine dba Baylor Scott & White Medical Center - Grapevine (BSW Grapevine) is a faith-based, non-profit, 302-bed acute care hospital providing exemplary patient care to Grapevine, Texas and the surrounding communities BSW Grapevine provides inpatient and outpatient medical services to treat individuals with diseases, illnesses and injuries of varying complexities Comprehensive services include all offerings typical of a quality acute care hospital with multidisciplinary interaction among physicians to help provide patients with innovative methods of prevention, diagnosis, treatment, education and support These services include comprehensive care for all stages of illness through all stages of life The organization is affiliated with Baylor Scott & White Health (BSWH), a faith-based nationally acclaimed network of acute care hospitals and related health care entities providing quality patient care, medical education, medical research and other community services to the residents of North and Central Texas As the largest not-for-profit health care system in Texas and one of the largest in the United States, BSWH was born from the 2013 combination of Baylor Health Care System and Scott & White Healthcare Today, BSWH includes 48 hospitals, more than 1,000 patient care sites, more than 5,500 active physicians, over 44,000 employees and the Scott & White Health Plan During the fiscal year, BSW Grapevine admitted 12,501 patients resulting in 56,466 days of care, delivered 2,406 babies and received 40,762 emergency department visits Additionally BSW Grapevine provided community benefits (as calculated in accordance with the State of Texas Statutory methodology) of \$38,198,786 and provided community benefits (as reported on the IRS Form 990, Schedule H) of \$10,918,610 during the tax year The Texas Annual Statement of Community Benefit Standard includes approximately \$27,020,565 of unreimbursed cost of Medicare that is not included in the IRS Form 990, Schedule H See schedule H for more information regarding these services and how BSW Grapevine promotes the health of the communities

Despite all of the effort and ways the organization educates patients about qualifying for its charity care program as demonstrated in Part VI, question 3 below, many uninsured patients either refuse or fail to complete a charity care application or provide sufficient information at the time of admission, during their stay or after being discharged to qualify for assistance under the organization's charity care policy.

Using the same methodology to calculate the unreimbursed cost of providing charity care and Medicaid (using applicable Schedule H Worksheets) would result in a shortfall of \$23,731,541, which is \$10,071,967 higher than the shortfall reported on Part III, Section B, Line 7. The organization believes that all of the shortfall should be considered as a community benefit for the following reasons. First, the IRS Community Benefit Standard includes the provision of care to the elderly and Medicare patients. IRS Revenue Ruling 69-545 provides, in part, that hospitals serving patients with governmental health benefits, including for example Medicare, is an indication that the hospital operates for the promotion of health in the community. Second, the organization provides care to Medicare patients regardless of this shortfall, i.e., loss, and thereby relieves the state and federal government of the burden of paying the full cost for the care of Medicare beneficiaries. Medicare does not provide sufficient reimbursement to cover the entire cost of providing care to these patients causing the organization to use other surplus funds to cover the shortfall. It is expected that reimbursement under the Medicare program will continue to decline and therefore may further limit access to care due to the anticipated reduction of participating Medicare providers in the community. As a result, the care for these patients will likely increase at, and rest on the shoulders of, nonprofit hospitals or county hospital districts. Third, many of the Medicare participants have low fixed incomes and therefore would qualify for charity care or other means tested government programs absent being enrolled in the Medicare program. Fourth, Texas nonprofit hospitals must provide a minimum level of community benefit in order to obtain exemption from state and local taxes. According to the current Texas Health and Safety Code, the unreimbursed cost of Medicare is considered to be a community benefit in determining these state statutory requirements as it helps relieve a governmental burden of providing this care that would otherwise be provided through the county hospital system in Texas.

The community, overall, appeared to be at an advantage in terms of fewer social barriers experienced by its population. Over 2.8 million people resided in the community served by the hospital facilities. A majority (66%) of the population for this community is located in Tarrant County. The population of the community is expected to grow 8% (220,502 people) by 2020. The 8% population growth is slightly higher compared to the state growth rate (6.7%) and higher compared to the national growth rate (3.5%). Johnson County had the smallest population in the community and will experience the smallest growth (6%) by 2020. Denton County will grow the most (10%) over the next 5 years. The ZIP codes expected to experience the most growth in five years: 76063 Mansfield - 8,166 people and 76179 Fort Worth - 6,909 people. None of the ZIP codes in this area are expecting a decline in population, however, several ZIP codes are not predicted to experience a population increase. Denton County is predicted to have a larger amount of growth in two age groups when compared to the remaining community, those 45-64 and 65+ year of age. The age 65+ cohort is predicted to experience the largest increase in residents in Denton, Johnson and Tarrant counties, adding approximately 84,000 people. Those less than 18 years of age are predicted to experience the least amount of growth (25,483 people). Total population can be analyzed by race or by Hispanic ethnicity. The graphs that follow display the community's total population breakdown by race (including all ethnicities) and also by ethnicity (including all races). Seventy percent (70%) of the community's population was white and Tarrant County made up a majority of white population for the community. However, diversity in the community is projected to increase over the next five years. Denton and Johnson counties will experience a growth in the African American and 2+ races populations of over 20%. The Hispanic population will grow approximately 14%, about 100,000 people, while the non-Hispanic population is expected to grow by only 6% over the next 5 years. Those of Hispanic ethnicity comprised approximately 25% of the community's population - below the state's proportion of Hispanics. The median household income for the community served was \$60,593, greater than both the state and U.S. benchmarks. More than two-thirds of the population was commercially insured. Commercial covered lives are expected to grow 9% (155,000 people) by 2020. Medicare and dual eligible lives (those receiving both Medicare and Medicaid benefits) are expected to experience the largest percentage increases of 21% and 27%, respectively. The number of uninsured and Medicaid lives will show a modest decrease. Johnson County is expected to experience a 5% decline in the number of uninsured and a 3% decline in Medicaid covered lives. Denton and Tarrant counties will decline by 1% in both uninsured and Medicaid covered lives. Medicare covered lives will experience the largest amount of growth in Denton County at 37%, compared to Johnson and Tarrant counties at a 20% and 25% increase. The community includes eight (8) Health Professional Shortage Areas and five (5) Medically Underserved Area as designated by the U.S. Department of Health and Human Services Health Resources Services Administration.

The organization provides financial assistance in the form of charity care to patients who are indigent and satisfy certain requirements. Additionally, the organization is committed to treating patients who are eligible for means tested government programs such as Medicaid and other government sponsored programs including Medicare, which is provided regardless of the reimbursement short fall, and thereby relieves the state and federal government of the burden of paying the full cost of care for these patients. Often, patients are unaware of the federal, state and local programs open to them for financial assistance, or they are unable to access them due to the cumbersome enrollment process required to receive these benefits. The organization offers assistance in enrollment to these government programs or extends financial assistance in the form of charity care through the organization's Financial Assistance Policy which can be located on the organization's website at https://www.bswhealth.com/financialassistance. The organization operates an emergency department accepting all patients without regard for their ability to pay. The emergency department provides coverage 24 hours a day, seven days a week. The expanded 23,000 square foot facility is equipped with bedside check-in and triage, and advanced scanning equipment to speed a patient's diagnosis and treatment. The organization is also committed to promoting the health and well-being of individuals and families beyond the health activities of the traditional hospital or clinic setting through its community outreach programs. Community outreach and preventive health care are important areas of focus that fuel the organization's efforts to screen and educate local residents to improve the overall health and wellness of the community its services. Prevention leads to early detection and the ability to catch disease when treatment will be most reliable and effective. These programs are targeted to positively alter the health of the community by providing education on such topics as adult nutrition, childhood obesity, and behavioral health issues and to build support groups for individuals suffering with chronic diseases such as diabetes, cardiovascular and pulmonary diseases, and cancer. Throughout the year the organization offers free preventive health services to the community such as health screenings, health fairs, immunizations and many other community education programs. Equipping people with quality health information encourages individuals to make appropriate life style changes to benefit their health. As part of a health system with renowned teaching facilities, the organization attracts first-rate medical specialists who help improve the level of medical care for the entire community. The organization is also committed to assisting with the preparation of future nurses at entry and advanced levels of the profession to establish a qualified workforce. During a nurses training, clinical skills and professional competencies are developed to provide the nurse with the ability to take on increasing responsibility for patient
