FAMILY STABILITY PROGRAMS RAPID REHOUSING - IN 2015, THE RAPID REHOUSING PROGRAM ENDED HOMELESSNESS FOR FAMILIES. A TOTAL OF 368 INDIVIDUALS WERE SERVED BY THIS PROGRAM. FOOD PANTRY - THE FOOD PANTRY DISTRIBUTED A TOTAL OF \$27,016 WORTH OF GROCERIES TO A TOTAL OF 69 FAMILIES. ALL OF THE DISTRIBUTED FOOD AND HYGIENE ITEMS WERE DONATED BY LOCAL ORGANIZATIONS IN THE COMMUNITY. BASIC NEEDS - THE ALLIANCE ALSO ASSISTED OUR FAMILIES WITH OTHER BASIC NEEDS IN 2015. ACROSS ORANGE COUNTY, 92 GIFT CARDS AT A TOTAL OF \$1,818.77, \$10,038.17 IN BUS PASSES (100 PEOPLE SERVED), AND \$5,550 WORTH OF GAS CARDS (48 PEOPLE SERVED) WERE DISTRIBUTED.
