YELLOWSTONE ACADEMY IS A PRIVATE, FAITH BASED SCHOOL IN HOUSTON'S THIRD WARD THAT SERVES STUDENTS FROM PRE-K THROUGH THE 8TH GRADE, AND ALUMNI ATTENDING VARIOUS HIGH SCHOOLS IN HOUSTON. YELLOWSTONE ACADEMY OPENED ON AUGUST 21, 2002 WITH FOUR CLASSES OF THREE AND FOUR YEAR OLD STUDENTS. DURING THE 2015-2016 SCHOOL YEAR, YELLOWSTONE ACADEMY SERVED 322 STUDENTS FROM PRE-KINDERGARTEN THROUGH THE EIGHTH GRADE AND AN ADDITIONAL 77 GRADUATES THROUGH THE HIGH SCHOOL SUPPORT PROGRAM. ONE HUNDRED PERCENT OF THE STUDENTS SERVED WERE FROM LOW INCOME FAMILIES WHO LIVE IN NEIGHBORHOODS WITH FAILING SCHOOLS. THROUGH DONORS' GENEROSITY, EACH STUDENT RECEIVED A SCHOLARSHIP THAT COVERED 99% OF THE COST OF ATTENDANCE. YELLOWSTONE ACADEMY IS COMMITTED TO LEVELING THE ACADEMIC PLAYING FIELD FOR OUR STUDENTS WITH OUR COMMUNITY'S SUPPORT. OF THE 27 HISD ELEMENTARY AND MIDDLE SCHOOLS OUR STUDENTS WERE ZONED FOR, 70% RECEIVED A FAILING SCORE FROM CHILDREN AT RISK, AND THE OTHER 30% WERE RANKED D. THE ACADEMY'S WORK HAS NEVER BEEN MORE URGENT AS THE SCHOOL IS STANDING IN THE GAP FOR HUNDREDS OF STUDENTS PROVIDING THEM WITH A HIGH QUALITY EDUCATION AND OPPORTUNITIES THAT THEY OTHERWISE WOULD NOT BE ABLE TO ACCESS. YELLOWSTONE'S ACADEMIC PROGRAM IS DESIGNED TO ENCOURAGE STUDENTS TO MAKE SIGNIFICANT ACADEMIC GAINS EACH YEAR. STUDENTS AND FAMILIES COMMITTED TO A LONGER SCHOOL DAY AND AN EXTENDED SCHOOL YEAR TO MAXIMIZE LEARNING TIMES THROUGH CLASS SIZES THAT AVERAGED 16 STUDENTS, INSTRUCTIONAL STAFF DELIVERED HIGH QUALITY INSTRUCTION WITH A FOCUS ON READING AND MATH MASTERY TO SUPPORT CLASSROOM INSTRUCTION AND LEARNING, YELLOWSTONE INVESTED IN THINK THROUGH MATH AND I-STATION READING ASSESSMENT WHICH EQUIPPED TEACHERS WITH REAL TIME PERFORMANCE DATA SO THAT THEY CAN ADAPT LESSONS TO INDIVIDUAL STUDENTS. YELLOWSTONE'S EARLY INVESTMENT IN OUR PRE-KINDERGARTEN STUDENTS CONTINUES TO SHOW BENEFITS AS STUDENTS MATRICULATE THROUGH THE SCHOOL'S PROGRAM. 100% OF PRE-K 4 STUDENTS WERE ON TRACK TO BE WELL PREPARED FOR KINDERGARTEN IN READING ACCORDING TO THE TEXAS SCHOOL READY PROJECT ASSESSMENT AND, FOR THE SECOND YEAR IN A ROW, THE MAJORITY OF YELLOWSTONE 8TH GRADERS SCORED AT A HIGH SCHOOL LEVEL IN READING AND MATH ON THE IOWA TEST OF BASIC SKILLS. THE SCHOOL IS DETERMINED TO PUSH OUR STUDENTS TOWARDS ACADEMIC EXCELLENCE AND HAS HIRED A NEW DIRECTOR OF ACADEMICS TO GUIDE THE SCHOOL DURING THE 2015-2016 SCHOOL YEAR, YELLOWSTONE PROVIDED DAILY TRANSPORTATION FOR STUDENTS, CONTINUED DAILY BREAKFAST AND LUNCH SERVICE, AND DISTRIBUTED UNIFORMS AND SCHOOL SUPPLIES TO STUDENTS. THESE TOOLS HELPED TO ENSURE THAT OUR STUDENTS WERE ABLE TO FOCUS ON THEIR ACADEMIC GOALS. ADDITIONALLY, YELLOWSTONE ACADEMY PROVIDED SOCIAL SERVICES THAT INCLUDED GROUP AND INDIVIDUAL COUNSELING, ACCESS TO HEALTHCARE SERVICES, AND FAMILY AND PARENT PROGRAMMING. YELLOWSTONE'S COMMUNITY PARTNERS INCLUDED HOUSTON FOOD BANK, CHRISTUS HEALTH, TEXAS CHILDREN'S HOSPITAL, CHILDBUILDERS, INTERFACE SAMARITANS, UNIVERSITY OF HOUSTON, UT SCHOOL OF DENTISTRY, AND PROJECT SMILES. THE ACADEMY REMAINS COMMITTED TO PROVIDING OUR STUDENTS WITH HOLISTIC SUPPORT. YELLOWSTONE ACADEMY INSTILLS IN OUR STUDENTS CHRISTIAN VALUES TO GUIDE THEIR LIVES. STUDENTS ATTENDED BIBLE CLASS EACH SCHOOL DAY, AND ONCE A WEEK THE CAMPUS GATHERED TOGETHER FOR A SCHOOL WIDE CHAPEL SERVICE. THE SCHOOL ALSO PROVIDED OPPORTUNITIES FOR OUR STUDENTS TO PUT THEIR BELIEFS INTO PRACTICE THROUGH COMMUNITY SERVICE LIKE SCHOOL CLEAN UP DAYS AND FOOD BOX DISTRIBUTION TO HOUSTONIANS IN NEED. THE ACADEMY RECOGNIZES THAT OUR STUDENTS' SUCCESS IS NOT ONLY LINKED TO THEIR ACADEMIC ACHIEVEMENT, BUT ALSO TO THEIR ABILITY TO MAKE POSITIVE CHOICES UNDER DIFFICULT CIRCUMSTANCES. TO SUPPORT THEM, THE SCHOOL PARTNERED WITH HUNDREDS OF VOLUNTEERS WHO MENTORED STUDENTS BY SERVING AS SHEPHERDS, TUTORS, CLASSROOM ASSISTANTS, AND FIELD TRIP CHAPERONES. ALSO, STUDENTS WERE PARTNERED WITH LOCAL CHURCHES, CIVIC ORGANIZATIONS, AND COMPANIES TO CREATE OPPORTUNITIES FOR MEANINGFUL RELATIONSHIPS WITH MEMBERS OF THE HOUSTON COMMUNITY. YELLOWSTONE ACADEMY IS COMMITTED TO PREPARING OUR GRADUATES FOR SUCCESS IN HIGH SCHOOL, COLLEGE, AND BEYOND. THE ACADEMY NOW HAS 98 EIGHTH GRADE GRADUATES. 100% OF YELLOWSTONE ACADEMY'S CLASS OF 2016 HAS BEEN ADMITTED TO A HIGH QUALITY HIGH SCHOOL THAT WILL PREPARE THEM FOR COLLEGE. DURING THE 2015-2016 SCHOOL YEAR, YELLOWSTONE WORKED WITH 77 GRADUATES WHO ARE ATTENDING 22 HIGH SCHOOLS THROUGHOUT HOUSTON. GRADUATES WERE PARTNERED WITH TUTORS FOR THEIR HIGH SCHOOL COURSES, GIVEN EMOTIONAL AND SPIRITUAL SUPPORT, AND ASSISTED WITH COLLEGE ENTRANCE PROCESS INCLUDING EXAM PREPARATION, APPLICATIONS, AND ENROLLMENT. OF OUR FIRST CLASS OF 8TH GRADE GRADUATES, 92 PERCENT WILL GRADUATE FROM HIGH SCHOOL THIS YEAR. COLLECTIVELY THIS CLASS RECEIVED MORE THAN 50 COLLEGE ACCEPTANCES. IN ADDITION TO ATTENDING COLLEGE, YELLOWSTONE GRADUATES WILL BE ENTERING THE MILITARY AND PURSUING POST-SECONDARY CERTIFICATIONS. THE SUCCESS RATE OF OUR GRADUATES DEMONSTRATES THAT YELLOWSTONE ACADEMY IS MAKING A DIFFERENCE.
