The articles regarding the Board composition were changed to read, "No Member of the Board of Corporators for the Catholic Foundation of Maine, except for the Roman Catholic Bishop of Portland and any Coadjutor or Auxiliary Bishop or Moderator of the Curia may serve as a Trustee of the Foundation." The stipulation that "there shall at all times be at least two (2) priests of the Diocese" serving on the Board was removed from both governing documents. The portion of the article stipulating that the majority of Trustees are laypeople was retained. The portion of the bylaws determining allowable terms of services was updated to allow the Board Chair to serve an extra year after the term as officer ends, even if it extends the overall Board term for one year beyond the normal maximum of six years. The minimum number of Trustees required for a quorum was increased from 40% to a majority then in office.
