As a result of offering KVTA's Learn to Play program through area Adult Education programs, this program has doubled in size.

Many early participants are now members of regular weekly groups of tennis players.

The Orange Ball (8-12 yr. olds) and Middle School and High School programs have also seen increased participation

Our tennis Pros are busier than ever with skills clinics, Triples tennis, and Cardio tennis.

We continue to offer popular Friday Night Mixers and periodic Saturday Scrambles.

For competitive players, there were three USTA League Tennis teams that played against other Maine club teams January-June 2016
