Overture Band Programs, Inc. is dedicated to providing instrumental music education and music opportunities to students in private and parochial schools and to home-schooled students in Dane County, WI through quality band programs.

Overture Band Programs, Inc. provided band programs to 19 private, parochial and home-school organizations in Dane County, WI that would otherwise be unable to offer and provide instrumental music education to their students. Four hundred seventy-one (471) students from those 10 schools participated in Overture's band programs for the 2015-16 school year. Overture Band Programs, Inc. had three full-time instructors and two part-time instructors employed to provide these services. Thirteen families from seven schools received a combined total of \$914 in tuition assistance from Overture Band Programs, Inc.

Music instruction provides students with academic and aesthetic experiences that enhance and enrich the quality of their comprehensive education and their lives, and serves as an avenue for creativity, self-awareness and self-expression. Music education also increases a student's self-confidence and positively influences the development of higher cognitive processes and enhances one's spatial intelligence.

4b (Code:) (Expenses \$ 4199 including grants of \$ 0) (Revenue \$ 3760)

Overture Band Programs, Inc. offered its students the opportunity to take individual lessons over the summer through a four or five week Summer Lesson Program. Forty-one students from six participating schools received half-hour private lessons from an Overture instructor (employee) for four or five weeks during the summer. Three of Overture's employees were instructors for this program.

4c (Code:) (Expenses \$ 5742 including grants of \$ 0) (Revenue \$ 2736)

Overture Band Programs, Inc. offers its more advanced students the opportunity to participate in Overture's Honor Band, Jazz Band and in the Wisconsin School Music Association's Solo & Ensemble Festival. Forty (40) students from eleven schools participated in the WSMA District Solo & Ensemble Festival in February 2016 where they prepared thirty-seven (37) solos and three ensembles and performed them for an adjudicator. Students received a rating and comments regarding their performance from the adjudicator. Solo & Ensemble Festival taught students to improve their music skills and to reach a higher level of performance. It also helps students gain poise and self-confidence. Two students advanced to the State level.

Honor Band and Jazz Band provide the students that participate the opportunity to expand their music repertoire, play music that is more challenging (both technically and musically), have a larger group band experience, and perform 7 concerts throughout the school year. Forty (40) students from twelve schools participated in Honor Band where they rehearsed together for 1 1/2 hours once a week for nine weeks each semester. Ten students from six schools participated in Jazz Band, rehearsing together 1 hour once a week for nine weeks each semester. Four Overture employees were instructors for these groups. Students who participate in Honor Band & Jazz Band share what they learn with their peers in their own school bands through the leadership and maturity they gain.
