LEADERSHIP DEVELOPMENT, ORGANIZING & CIVIC ENGAGEMENT This year we graduated 15 new leaders from our leadership development program to serve on boards, committees and other leadership bodies. We also solidified organizing programs, developing a base of 80 youth, 20 college students, and 20 young parents. In civic engagement, we registered 5,083 new voters and trained 135 volunteers. We also funded 6 API led partner organizations to participate in civic engagement activities.

POLICY ADVOCACY This year we brought 100 community leaders to educate decision makers on issues impacting the Asian Pacific Islander community of Oregon on health, education and economic achievement. This led to new policies and reforms to close achievement gaps. We also built up member organizations around the state to open communication and coordination statewide.

JADE DISTRICT. We participated in local community development work including operating an 8,200 sq foot community center, engaging the community on public planning processes, and holding a night market to promote our business district with 25,000 visitors. We also hosted numerous community charettes for community projects with 200 participants. Our arts and culture program sponsored 8 artists to create art focused on our target neighborhoods.
