Immanuel Lutheran Corporation of Kalispell, Montana was incorporated in the State of Montana on September 7, 1953. It is an affiliated social ministry organization recognized by the Evangelical Lutheran Church in America and its membership consists of those Lutheran congregations affiliated with the Montana Synod, but operates independently and bears sole responsibility for its fiscal solvency. As a not-for-profit corporation (DBA-Immanuel Lutheran Communities), it operates a 139 bed skilled nursing facility (DBA-Immanuel Skilled Care Center "ISCC"), a 16 bed rehabilitation facility (DBA-The Retreat at Buffalo Hill) and a 112 apartment independent and assisted living facility (DBA-Buffalo Hill Terrace "BHT"). Immanuel Lutheran has grown into one of the largest continuing care retirement communities in the State of Montana. Program Services Accomplishments: ISCC and the Retreat provided 32,869 days of care to its elderly and disabled population. Immanuel Lutheran was one of the largest providers of Medicaid long-term care in Flathead County providing 18,142 days of care. The short-fall to provide care to Medicaid recipients and the reimbursement received is about \$1,032,000 for the fiscal year ending June 30, 2016. Services provided to all nursing home residents are skilled nursing, assistance with activities of daily living, physical therapy, occupational therapy, speech therapy, social and recreational activities, pastoral services, meals, housekeeping and laundry. Buffalo Hill Terrace had a total resident day census of 38,456 days for the fiscal year which equates to a 94% occupancy. BHT served on average 45 assisted living residents a day. Along with assisted living, other services available to all residents are rehabilitative services, social and recreational activities, pastoral services, dining, housekeeping and laundry. Social Accountability Report: In keeping with our Mission Statement, listed here are ways that Immanuel Lutheran serves the community in which we work and serve. Donated our refurbished 1999 Champion Bus to the Flathead Lutheran Bible Camp (estimated value - \$10,000). Members of the Kalispell Chamber participated in the Annual Banquet Fundraiser. We also hosted four blood drives for the American Red Cross and we are a member of the Kalispell Rotary and contributor to the "The Rotary Foundation Annual Fund". We are a sponsoring member of the Hockaday Museum of Art. We participated in the United Way combined campaign. We provide dinner once a month for thirty people at the Abbey Shelter, for fifty people for the "Feed the Flathead" and about thirty sack lunches for Habitat for the Humanity (estimated value - \$7,800). When we have leftover food from dinner or an event, we donate that to the Boys and Girls Club. We donated 50 doors, 36 cabinets, 3 wheelchairs, 5 walkers and 1 exercise machine to ReStore (estimated value - \$29,244). We donated clothing to Second Helpings Thrift Store. We donated 40 wardrobe cabinets to the Montana Veterans Home for their remodel. We donated to a fundraiser to support the foundation at Flathead Valley Community College and supported the Community Performance Arts and Theatre fundraiser. Staff volunteered to help with the Community Foundation annual events. At Christmas, staff rang the bell for the Kettle Drive and Immanuel hosted an Angel Tree along with a canned food drive to benefit the Salvation Army. Staff members currently serve on the following boards and other related community services projects: Montana Health Care Association, Montana Hospital Association, National/Montana Alzheimer's Association, Rotary, Leadership Flathead, Montana Ambassadors Board, Area Agency on Aging, Flathead County Healthcare Coalition, Kalispell Chamber of Commerce, Glacier Symphony and Chorale, Geriatric Care and Mental Health Advisory Council, United Way Board, and the Montana Board of Nursing Home Administrators. In addition, Immanuel Lutheran Communities shows environmental citizenship by recycling cardboard, plastic, paper, aluminum cans as well as composting 44 tons of food waste annually.
