HERITAGE ACRES IS A 36-BED NURSING CARE FACILITY AND A 10-UNIT ASSISTED LIVING AND 10-UNIT INDEPENDENT LIVING DURING THE YEAR ENDED JUNE 30, 2016, BIG HORN COUNTY MEMORIAL HOSPITAL PROVIDED 569 DAYS OF INPATIENT SERVICES, 8,372 OUTPATIENT VISITS (INCLUDING 4,580 ER VISITS) AND 2,427 DAYS OF RESIDENT SERVICES. HERITAGE ACRES PROVIDED 12,287 DAYS OF LONG TERM CARE RESIDENT SERVICES, 3,136 DAYS OF ASSISTED LIVING RESIDENT SERVICES.
