OUR 2015 STATS ARE BASED UPON THE CALENDAR YEAR. DURING 2015 WE SERVED OVER 18,414 INDIVIDUALS IN OUR STORE WHICH AMOUNTED TO 73,102 TOTAL STORE SERVICES. THE NUMBER OF DIFFERENT HOUSEHOLDS THAT WERE SERVED DURING THE YEAR WAS 5,648. OF THE PEOPLE SERVED 34% WERE CHILDREN 18 AND UNDER AND 14% WERE SENIORS. IN ADDITION, THE MISSOULA FOOD BANK SERVED 6,670 INDIVIDUALS FOR THE THANKSGIVING HOLIDAY, AND SERVED AN ADDITIONAL 1,083 HOUSEHOLDS IN THE LOLO AND POTOMAC AREAS. THE TOTAL AMOUNT SERVICED FROM ALL THE PROGRAMS WAS 119,113 EACH MONTH. ROOTS DELIVERS NUTRITIOUS USDA APPROVED FOOD TO HOME-BOUND SENIORS IN THE COMMUNITY. ROOTS PARTICIPANTS ARE OVER THE AGE OF 60 AND LIVING ON LESS THAN 130% OF THE POVERTY LEVEL. SENIORS ARE THE FASTEST GROWING POPULATION OF PEOPLE WHO COME TO THE MISSOULA FOOD BANK. APPROXIMATELY 125 VOLUNTEERS WORK 121 HOURS TO ASSEMBLE AND DELIVER THESE FOOD BOXES. DURING 2015, 4,620 ROOTS HOMEBOUND CLIENT BOXES WERE SERVED. THE KIDS EMPOWER PACK PROGRAM IS A WEEKEND NUTRITION PROGRAM HELPING KIDS STAY HEALTHY AND NOURISHED WHILE SCHOOL IS NOT IN SESSION. KIDS IN THE PROGRAM ARE IDENTIFIED BY SCHOOL OFFICIALS WHO RECOGNIZE BEHAVIORS AND CIRCUMSTANCES OF CHILDREN LIVING IN CHRONIC HUNGER AT HOME. APPROXIMATELY 12,524 EMPOWER PACKS WERE PROVIDED TO KIDS. THE KIDS TABLE PROGRAM PARTNERS WITH LOCAL CHILDCARE PROGRAMS TO HELP FEED HUNGRY KIDS. IT ALSO OFFERS FREE LUNCH TO CHILDREN AT OPEN MEAL SITES IN THE SUMMER. NUTRITIONALLY BALANCED MEALS AND SNACKS ARE OFFERED TO THE KIDS. THE PROGRAM PROVIDED 16,679 MEALS IN THE SUMMER PROGRAM AND 11,105 AFTER SCHOOL MEALS. THE MISSOULA FOOD BANK RECEIVED 1,188,345 POUNDS OF DONATED FOOD AND GAVE AWAY 1,534,934 POUNDS OF FOOD. APPROXIMATELY 16,205 POUNDS WERE DONATED TO THE OTHER FEEDING AGENCIES FOR SEVERAL YEARS. THE FOOD BANK BOARD OF DIRECTORS HAS KNOWN THAT THE CURRENT SITE AT 219 S 3RD ST W IS NOT ADEQUATE TO MEET THE NEEDS OF FOOD INSECURE HOUSEHOLDS HERE IN MISSOULA. IN 2015-16, MISSOULA FOOD BANK RAISED RESTRICTED FUNDS IN A CAPITAL CAMPAIGN FOR A RELOCATION PROJECT, ENGAGING COMMUNITY LEADERS IN CAMPAIGNING AND ASKING FOR LARGER GIFTS THAN EVER BEFORE IN OUR HISTORY. THIS CAMPAIGN WAS SUCCESSFUL, AND MISSOULA FOOD BANK PLANS TO RELOCATE TO A NEW FACILITY IN THE SPRING OF 2017.
