185 adults (16 and older and not enrolled in public school) received direct instruction to enable them to function on the job, within their families, and in society. 42 students completed their high school equivalency diploma. 18 graduates entered postsecondary education or training. The state data base was changed last year so we do not have accurate data for those who entered the workplace or gained or retained employment, but many of our students are working.

Explanation of grants: 48 students received scholarships for testing fees for the High School Equivalency exam, ranging in amount from \$10 to \$75 per person and totaling \$2,088. Payments were made directly to the test vendors and testing centers so the funds could not be used for any other purpose.

English Language/Civics Instruction for 12 adults seeking to speak English better and to become participants in the community or to gain citizenship
