The Traveling School believes informed, inspired, and confident young women can change the world. We provide an exceptional semester of learning and growth for high school age females in southern Africa and South America. Our four-part focus includes inspiring academics, cultural engagement, outdoor adventure, and leadership development. Our students return home global citizens who are passionate and motivated to positively impact their communities. This year, 14 students attended our fall semester, and 16 students joined us in the spring. These students represented 14 states across the U.S. as well as France. 43% of these students received financial aid due to the generous support of our donors. Financial aid awards totaled \$77,000, an increase of 35% from last year. Our continuing goal is to make this semester a reality for any globally minded and adventurous young woman.
