This network of individual donors has helped raise over \$100,000 in funds to support Latino-led grass root organizations across California. LCF hosts quarterly and annual convenings with this donor base to help educate, grow, and expand philanthropic efforts by Latinos

Transform - LCF invests in Latino-led organizations through its grantmaking and capacity building services. LCF awards grants to organizations working on creating opportunities for Latinos to thrive in the areas of health, education, civic engagement and leadership development. LCF provides core operating support to these emerging non-profits. LCF staff also works closely with Latino-led non-profits to strengthen their operations, communications, and fundraising skills. The ultimate goal is that these organizations become anchor institutions capable of transforming their communities into places where youth and families can thrive

Empower - LCF is working to build political power of Latinos by advancing a California Latino Agenda. LCF also facilitates legislative visits for community leaders to meet with decision makers and discuss opportunities for collaboration that will ultimately lead to improving the wellbeing of Latinos in California.
