THE COMMUNITY LIBRARY INCLUDES A MAIN LIBRARY, A CHILDREN'S LIBRARY AND A REFERENCE LIBRARY. APPROXIMATELY 128,000 VISITORS CAME TO THE COMMUNITY LIBRARY IN THE PAST FISCAL YEAR, AND MORE THAN 117,000 ITEMS WERE CIRCULATED. THE COLLECTION INCLUDES MORE THAN 80,000 PHYSICAL CIRCULATING ITEMS, AND ALSO NUMEROUS DIGITAL RESOURCES, INCLUDING ACCESS TO ONLINE DATABASES AND LEARNING PLATFORMS. ALL OF THESE SERVICES ARE PROVIDED TO THE PUBLIC FOR FREE.

THE REGIONAL HISTORY DEPARTMENT IS USED BY SCHOLARS, STUDENTS, AND VISITORS AS THEY RESEARCH AND STUDY THE HISTORY OF THE SUN VALLEY AREA AND CENTRAL IDAHO GENERALLY. IT ALSO HOSTS PUBLIC PROGRAMS, SUCH AS AN ORAL HISTORY WORKSHOP AND SESSIONS OF THE ANNUAL HEMINGWAY FESTIVAL.
