Applicants are required to write an essay, provide transcripts, and if applying for scholarships requiring financial need applicants must include the Free Application for Federal Student Aid report (FAFSA). Other requirements may be included, depending on the scholarship. During fiscal year end June 30, 2016, the Foundation distributed 1,610 scholarship awards to 1,278 recipients.
