Mental Health Services FCS provided 14,962 hours of service (109% of expected) to 743 individual enrolled clients. These clients were seen for services 12,818 times. Of these 743 enrolled clients, 72% were adult, 28% were under age 18, 45% were male, 55% were female, 3% were Veterans. The main source of referral for mental health services was through self-referrals. 92% of clients saw improved functioning, 56% completed treatment successfully. Average wait time for a mental health intake was 7 days.

4b (Code) (Expenses \$ 572,422 including grants of \$ 4,347) (Revenue \$ 728,676)
Substance Abuse Services FCS provided 8,849 hours of service (119% of expected) to 436 individual enrolled clients. These clients were seen for services 5,107 times. Of these 436 enrolled clients, 96% were adult, 4% were under age 18, 62% were male, 38% were female, 4% were Veterans. The main source of referral for substance abuse service was through the court systems. 91% of clients saw improved functioning, 55% completed treatment successfully. Average wait time for a substance abuse intake was 8 days.

4c (Code) (Expenses \$ 272,679 including grants of \$ 65,593) (Revenue \$ 125,264)
Community Services (Supported Independence Program - SIP) FCS provided 5,414 hours of services to 1,097 unenrolled individuals in Fremont County. These individuals were seen for services 3,099 times.
