The 77 grant programs supported by Wheat Ridge served a total of 58,279 unique individuals between July 2015 and June 2016. The grant programs supported by Wheat Ridge during the past year also engaged a total of 10,545 unique volunteers in service.

 Expenses for the education, training and support of professionals and other leaders in the Lutheran community that are involved in designing or operating projects. Wheat Ridge hosted and presented workshops at several events throughout the year including educational convenings for grantees and workshops for leaders interested in starting new health and human care ministry projects.

 Expenses incurred for the review, evaluation, selection and awarding of project grants, and support for internally funded and directed projects.
