Certain nonmember income, that would otherwise be taxable, may be set aside. Any income that the Grand Council has properly set aside must be used for the qualifying purposes outlined in the set aside resolution. Included in cash at June 30, 2016 and 2015 is \$43,274 and \$170,105, respectively, of funds set aside by the Grand Council. Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Fraternity and recognize a tax liability if the Fraternity has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has analyzed the tax positions taken by the Fraternity, and has concluded that as of June 30, 2016 and 2015, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Fraternity has filed its federal and state income tax returns for periods through June 30, 2015. These income tax returns are generally open to examination by the relevant taxing authorities for a period of three years from the later of the date the return was filed or its due date (including approved extensions).
