SEE SCHEDULE O FOSTER CARE SERVICES. IN FY2016, LFS SERVED 413 CHILDREN AND YOUTH IN 84 LICENSED FOSTER HOMES LOCATED ALONG THE FRONT RANGE AND EASTERN PLAINS OF COLORADO. THESE CHILDREN CAN BE REFERRED FROM ANY OF THE 64 COUNTIES IN COLORADO WHO RETAIN CUSTODY OF THE CHILDREN WHILE MANAGING THEIR INDIVIDUAL PERMANENCY PLAN OPTIONS WHICH INCLUDE REUNIFICATION WITH BIOLOGICAL PARENTS, KINSHIP CARE, ADOPTION, RELATIVE GUARDIANSHIP, ALLOCATION OF PARENTAL RIGHTS, AND OTHER PLANNED PERMANENT LIVING ARRANGEMENTS. LFS ALSO PROVIDES FOSTER CARE FOR UNACCOMPANIED REFUGEE MINORS (URM) WHO ARE REFERRED THROUGH THE US STATE DEPARTMENT OFFICE OF REFUGEE RESETTLEMENT. ALL SERVICES ARE REIMBURSED BY THE FEDERAL GOVERNMENT AND THESE CHILDREN/YOUTH CAN REMAIN IN FOSTER CARE THROUGH THE AGE OF 21. ONCE CHILDREN REACH THE AGE OF 18, THEY HAVE THE OPTION OF ENTERING INTO SUPPORTED INDEPENDENT LIVING WHERE THEY CAN LIVE AND PRACTICE SKILLS NEEDED TO SUCCESSFULLY TRANSITION TO SELF-SUFFICIENT ADULTHOOD. YOUNG PEOPLE MUST REMAIN ACTIVELY ENGAGED IN EDUCATION AND/OR EMPLOYMENT WHILE IN SUPPORTED INDEPENDENT LIVING. THERE WERE APPROXIMATELY 74 URM YOUTH LIVING IN COMBINED LFSRM FOSTER CARE AND SUPPORTED INDEPENDENT LIVING ON ANY GIVEN DAY DURING THE YEAR.

REFUGEE RESETTLEMENT SERVICES. LFSRM IS ONE OF THE LARGEST RESETTLEMENT PROGRAMS IN THE ROCKY MOUNTAIN REGION. IN COOPERATION WITH LUTHERAN IMMIGRATION AND REFUGEE SERVICES AND EPISCOPAL MIGRATION MINISTRIES (DENVER ONLY), WE WELCOME APPROXIMATELY 1,700 REFUGEES TO COLORADO AND NEW MEXICO EACH YEAR FROM WAR-TORN COUNTRIES AROUND THE WORLD. IN ADDITION, WE SERVE UP TO ANOTHER 500 SECONDARY MIGRANTS, ASYLEES AND VICTIMS OF TRAFFICKING WHO HAVE CHOSEN TO MAKE COLORADO OR NEW MEXICO THEIR HOME. LFSRM CURRENTLY PROVIDES REFUGEE SERVICES IN DENVER, COLORADO SPRINGS, GREELEY AND ALBUQUERQUE AND ALSO SERVES AS NEEDED IN THE STATE OF MONTANA.

LFS PROVIDES A RANGE OF PROGRAMS TO STRENGTHEN AND SUPPORT FAMILIES, IMPROVE FAMILY RELATIONSHIPS, AND EDUCATE CHILDREN AND FAMILIES ON SAFETY AND PARENTING TOPICS. PROGRAMS INCLUDE PARENTING EDUCATION, IN-HOME SUPPORT, BODY SAFETY CLASSES, SUPERVISED VISITATION, AND RESPITE CARE. ALONG THE NORTHERN FRONT RANGE, LFS PROVIDES PARENTING EDUCATION TO FAMILIES THROUGH COMMUNITY CLASSES, BODY SAFETY EDUCATION TO SCHOOL CHILDREN THROUGH THE SAFE TOUCH PROGRAM, AND SUPERVISED VISITATION AND SAFE-EXCHANGE SERVICES FOR PARENTS INVOLVED IN HIGH-RISK DIVORCES AND THOSE WHO HAVE OPEN CHILD PROTECTION CASES. ON THE SOUTHERN FRONT RANGE, LFS OFFERS SAFE CARE, AN EVIDENCE-BASED EARLY CHILDHOOD EDUCATION INTERVENTION OFFERED TO PARENTS IN THEIR HOMES FOR FAMILIES WITH CHILDREN AGES TWELVE AND YOUNGER TO CREATE SAFE, NURTURING AND STABLE ENVIRONMENTS FOR RAISING CHILDREN AND IMPROVING FAMILY RELATIONSHIPS. RESPITE SERVICES ARE PROVIDED IN EL PASO COUNTY TO ASSIST ANY PARENT OR GUARDIAN WHO NEEDS A BREAK FROM PARENTING, AND CRISIS CARE WHEN A CHILD CANNOT OR SHOULD NOT BE WITH THEIR PARENT OR GUARDIAN. THE COMBINED PREVENTION AND PARENT SUPPORT PROGRAMS SERVED APPROXIMATELY 14,000 INDIVIDUALS LAST YEAR. THE SAFE TOUCH PROGRAM ALONE SERVES OVER 11,000 ELEMENTARY-AGE CHILDREN EACH YEAR WITH IN-SCHOOL PRESENTATIONS IN EVERY ELEMENTARY SCHOOL IN WELD COUNTY, WHICH HAS LED NUMEROUS CHILDREN TO DISCLOSE SEXUAL AND PHYSICAL ABUSE TO THEIR TEACHERS, COUNSELORS, AND LFS STAFF.
