The total includes funds distributed as part of the collaborative nonprofit grant process focused on school readiness, youth success, high school graduation and post-secondary success, employment and job training, funds distributed as part of competitive nonprofit grant process focused on basic needs services, WomenGive childcare scholarships for single parents returning to school, grants provided for wildfire disaster relief efforts, support to Day Service Initiative for homeless programs in Larimer County, Estes Park United grants to youth programs in Estes Park area, BeReady Early Childhood Navigator services through Smart Start for Kids Initiative and support for 2-1-1 Information and Referral Services.

Colorado Reading Corps was launched in Thompson School District beginning in August 2014. Colorado Reading Corps is a nationally replicated model that utilizes AmeriCorps Members, trained in early intervention literacy strategies, to provide one-on-one tutoring to kindergarten through third grade students who are not reading at grade level. Upon completion of the second year of the program, results indicated that 738 students were served in 2015-16, of which 96.3% showed academic progress. Colorado Reading Corps is funded through a state grant from Serve Colorado, as well as matching funds from United Ways Smart Start for Kids Initiative. The tutoring program has had great success in school districts throughout Colorado, including Thompson School District, Jeffco Public Schools, Adams 12 Five Star Schools, Aurora Public Schools and Denver Public Schools.

The Long Term Recovery Fund for Larimer County floods was established in September to support the long term recovery efforts of households affected by the September 2013 floods. The mission of the LTRG-LCF is to address the unmet needs of those without resources to rebuild their homes and their lives through a case management process. The LTRG-LCF consists of a group of community organizations in Larimer County organized to provide coordinated management of the long-term recovery to residents affected by the flooding. They continue to evaluate/award grant dollars as residents exhaust all federal and state funding resources.
